Announcements:

UC Davis will release a new strategic plan tomorrow; various meetings will be held.

UC Riverside is interviewing the second candidate for Water Resources technical services librarian; primary duties will be cataloging and digitization.

Shibboleth discussion (Terry Toy)

The report of the original Shibboleth task force in 2010 recommended that LTAG coordinate communication regarding Shibboleth implementation. LTAG has established a sub-group to do this; members are Holly Eggleston, Dan Suchy, Tom Bustos (current LTAG chair) and John Ajao. Shibboleth is now used to authenticate access to the UCSF wiki and HathiTrust; all campuses except UCSB use it to access the DMP tool. UCM has implemented Shibboleth for authentication to EBL e-books. Terry asked HOTS to recommend possible candidates for Shibboleth implementation. HOTS recommended that the sub-group work with CDL to implement Shibboleth with Tier 1 vendors.

POT 7 LT2 survey (Rikke Ogawa)

HOTS responded to the survey regarding new roles for subject selectors/curators. Most of the responses focused on technical services issues affecting multi-campus models: lack of a single data base; lack of a shared back end; no access to multi-campus circulation data; CDL not being set up to produce multi-campus reports; lack of appropriate tools to facilitate multi-campus work. The uneven distribution of language expertise was also noted.

Action: Rikke will compile notes of the discussion and send to HOTS for vetting.

SPIP Guidelines (Karleen)

HOTS approved the message Karleen proposed to send to CAMCIG requesting follow-up work on the SPIP guidelines.

WEST Advisory Group (Patti)

The first substantial meeting occurred this week.

Action: A report on WEST activities will be added as a standing item to the HOTS agenda.

Melvyl update (Patti)

OCLC has agreed to work on fixing the HathiTrust record display issue. CDL continues to work with OCLC on the problem of inaccurate usage statistics. CDL is not going forward with the implementation of the OCLC Knowledge Base at this time. This decision will be revisited as the service matures.

NGTS update (Vicki)

The NGTS Management Team and SOPAG are discussing the following pilot projects with campuses:

- Systemwide receipt of shelf-ready monographs from YBP
- Implementation of MPLP guidelines for archival processing
- Cataloging of Chinese materials in campus backlogs
- Cataloging of audio CDs in campus backlogs
- Campus cataloging of electronic resources in cooperation with SCP; the focus will be on Tier 2 resources and those resources held by more than two campuses

Elizabeth Cowell and Virginia Steel are working on a public message regarding the reorganization of the advisory structure that should be sent out next week.
