Announcements, Housekeeping and Calendar Review

- Minutes from the February 22, 2019, meeting were reviewed and approved.
- Discussion of CDL one-time expenditure opportunities resulted in decision to supplement funding for JSTOR DDA pilot.

Elsevier

- Contract is in process for non-journal materials.
- Discussion of positions on offsetting agreements for journals continued.

STAR Team

- Team's recommendations of analytics tools for CDL one-time expenditures were discussed.
- Team presented proposal to clarify understanding of baseline criteria for resource reviews and the role of nominator/submitter, which JSCLG approved.

Shared Print Program

- CRL "Holes in the Print Safety Net" blog post, webinar and dataset were discussed.
- Analysis indicates that UC has archived access to 72% of JSTOR title list.
- Proposal that the regional library facilities (RLFs) are identified as contributing participants in the Journal Archiving Campaign Service (JACS), to allow more effective collection consolidation and space reclamation in alignment with retention policies, was discussed. Proposal has clear advantages, but the ownership of deposited journals for statistical and reporting purposes needs to be clarified.

Offsetting

- Terms of proposed agreement with Cambridge University Press were discussed.

CDL Licensing Updates

CDL Usage Statistics – CDL is implementing RedLink Consortia Dashboard for campuses to track usage statistics of system-wide licensed contents, with rollout the Dashboard in early Fall 2019. CDL will organize a webinar to introduce the dashboard and its interactive features to UC libraries. Due to staff shortage and a complicated transition from MPS ScholarlyStats to RedLink, CDL has not been able to

post the 2017 and 2018 Annual Usage Statistics Reports on CDL's website. We will provide these reports as soon as the RedLink implementation project is completed. We appreciate your understanding for the delay and will do our best to support campuses' needs. Please use cdlstats@ucop.edu to contact CDL staff for any questions related to CDL usage statistics or vendor admin login information.

CDL One-time Fund – SCLG and JSC will review and discuss suggested resources. CDL will make purchase decisions based on justification provided in submissions, funding availability, and the ease of licensing/acquisition, with SCLG/JSC input. All purchases will need to be for one-time purchases, for UC systemwide benefit.

- Cataloging Delay (if more than three months): A title may have been missed on the vendor title list, UC-eLinks (SFX) might have not yet been activated, the title might be missing the OCLC number, to name a few things that cause cataloging delays. It usually takes about two-three months for OCLC records to become available or for items to become available for SFX activation when new titles are added to an existing collection.
- Cataloging Errors: Please include the OCLC Number (preferred), ISSN, or ISBN in your inquiry.

CDL will be working on 2019 SienceDirect contract because some non-journal resources (ebooks, etc.) are continuing beyond 12/31/2018.
