Notes from UC Libraries/HOPS Conference Call June 21, 2010 3:30-4:45

Participants: DeDecker (SB), Frenkel (R), Friedman (SD), Hughes (UCI), Kautzman (D), Meltzer (CDL), Palmer (LAUC), Persily (SF), Stirling (B) Barclay (M), Cowell (SC) and Mulroy (LA) were not able to join us.

1. Announcements round robin

UCD: UL search has not worked out; Mary Page, AUL for Tech Services is leaving for a position in Florida.

CDL: Nature contract strategizing is occurring; existing contract goes through this year; CDL staff, Rachael Hu and Berkeley School of Information intern, Alison Meier, visited Davis to conduct a handful of in-person interviews with undergraduate students to learn about how they used their mobile devices and also how they conducted school-related work on these devices. They've also visited Berkeley and UCSF where they interviewed a mix of graduate, faculty and staff. (These campuses were selected campuses based on their proximity since we couldn't travel extensively to southern UC campuses.) They have also done phone interviews with non-UC constituents (Calisphere/OAC users).

UCB: AUL for Collections Chuck Eckman is leaving to be library dean at Simon Fraser University. UCSF: just launched a mobile website that can be viewed on a wide range of mobile devices (http://www.library.ucsf.edu/node/2235).

UCI: mobile website in beta.

2. Continuation of discussion of Systemwide Tutorial.

Cathy Palmer reports that UCI developers would charge \$5,062.62 to do a simple de-badging (strip out UCI references, make generic "find books" and "find articles".) Ellen Meltzer reports not much interest from CDL about using one of their servers (too small a project; CDL handles larger scale projects; concern about keeping up with versions of software, such as Flash). So far there is definite interest among 5 libraries to split the cost and pilot the use of the UCI "begin your research" tutorial (http://www.lib.uci.edu/how/tutorials/LibraryWorkshop/begin.html): UCM, UCD, UCSB, UCR, UCSD.

Action: Cathy Palmer will look into the possibilities of publishing this as an MP4 so it would be compatible with mobile devices and Mac.

Action: Ann Frenkel will find out the interest from the campuses not on this call. **Action**: Cathy Palmer will draft a brief proposal about the the tutorial project (use, cost, assessment) that we can use in discussing this with our campuses.

• Explore and monitor technologies such as services for mobile devices and identifying where we can collaborate.

Action: Sherry DeDecker will ask the Dig Ref CIG to send their activity report to HOPS by August 1.
