# <u>Updates from SILS Phase 4 Groups</u>

### Resource Management Functional Group (Liz)

- Just getting started on testing
- Charted out a decision calendar (includes deadline for consulting groups)
- Also starting a weekly study hall for Alma Vanguard
- Getting feedback on Slack channel

### **Acquisitions & E-Resource Functional Group (Sarah Sheets)**

Focused on testing Vanguard data

### **ILS Data Cleanup Group (TJ)**

- Alma campuses shared some of their normalization, merge, and indication rules
- Vanguard campuses shared their observation on migrated data. Lots of very good information that will help identify more critical data cleanup tasks and finetune existent ones
- The group is also working on a Google Sheet and Google Form to collect Network Zone bib record issues

#### SCP SILS Phase 4 Update (Shi)

- Reviewed data migrated into CDL IZ (temporary, for staging), overall looks good
  - A few records with bad 008
  - About 3000 records somehow missed from a file sent but ExL didn't report back to us; P2E portfolios from these bib records were not created
- CDL ERT (E-Resource Team)-SILS data group is trying to reconcile SFX/360 ERM/SCP 793

- CDL also has a CDL-SILS group with CDL rep to various SILS functional group members meeting biweekly, mostly sharing information on each functional group and CDL related SILS topics
- SILS PPC group on CDL data in NZ also met and prepared SCP workflow questions for ExL meeting on October 1 on SCP workflow

# **SCP Updates (Shi, Becky)**

Serials Phase 2 completed 93%, about 41,000 records. The remaining is less than 3000 records

- Becky works on converting serials from print to electronic; also on OECD titles
- ProjectMUSE DDA titles for discovery records, about 5000 records, have been removed; over 10,000 titles for PM have been distributed. Reconciliation for JSTOR titles is still ongoing, due to mess up with CDL account at JSTOR
- Project priorities for 2020Q4 has sent to CKGs for input: including:
  - New acquisitions Tier 2 titles/contents changes (platform, etc.);
  - Two open access collections, Getty Art & Architecture and WHO collection, coming up once approved
  - Serials Phase II
  - o For SILS, will review workflow after data moratorium until this Friday
- Please refer UC staff to use CDL helpline for issues, as SCP staff are busy with SILS workloads

#### Other

ISSN Portal: who subscribes? Number of users allowed? (Liz) - exploring consortial subscription?

- UCLA has 9 users
- Berkeley has 3 users
- UCD has 3 users and two are constantly used.
- CDL/UCSD has 2 users

## Vanguard Migration Issue: False matches (Kevin) -

- issues with SILS Vanguard multi match report, vast majority seem like false matches on microform EEBO collection with CZ OCLC numbers, reported to ExL who confirmed it shouldn't be working that way.
- This problem should be fixed for the test migration, but we do not know how these CZ records would interact with the NZ/IZ records post-migration, so further testing will be needed if SCP is considering using CZ records for EEBO.
