1. Announcements.

Jim Dooley was present for Sarah Sheets, who is on maternity leave after delivering a baby girl.

Kristen LaBonte (UCSB) was hired as the Life Sciences Librarian. She started on September 1st.

Sherry DeDecker (UCSB), AUL for User & Instructional Services, retired effective September 30th.

- 2. Next Generation Melvyl update (John).
- 1) The LHRs for serials got turned on in Melvyl last Monday (Sept 12). One reminder about the UC best practices: Don't send the URLs for e-resources cataloged by SCP, since it will causes duplicate URL display since SCP staff send in LHRs on our behalf with the xxxER symbols. Only send in URLs from campuses for locally-licensed access.
- 2) The series of webinars on Melvyl WorldCat Local has begun. The second one is next Tuesday, Sept 27 on technical services aspects; the third one will be Oct 11, covering UC's and OCLC's roadmaps for future developments. - 3) After four years of work the NGM Implementation Team has been dismissed as of last week. John may have less information to share with SCP AC in the future as a result. As HOTS chair, John will be ex officio on a new Melvyl Advisory Group that will have provisional existence for one year.
- 3. SCP update (Becky and Adolfo)

Becky and Aldolfo have discovered duplicated urls for licensed resources in situations where a campus has sent an LHR for both the SCP holdings and their local subscription holding. Adolfo noted that Irvine

and San Francisco urls were problematic. He asked each campus liaison to describe their LHR reporting process.

Action: Adolfo will follow up with Irvine and S.F. to help identify a processing solution.

Adolfo reported that EBBO has announced that they have about 30,000 new titles, and have enhanced many of the previously released 95,000 records. These are vendor records, and should not be sent to MELVYL/OCLC. It is not clear at this point if the records will have a match point for overlay, so it is likely that the best method for replacing the old records with the new ones would be for each campus to delete their old EEBO records from their catalog before loading the new records from SCP. Because of the large number of records, SCP will likely distribute them on CD-ROM. SCP will first review samples of these records and will keep the SCP AC updated.

SCP is still working on the Shaw Shoemaker file, and Becky expects to be sending out about another 500 records for this collection shortly. Also in process -- 17th & 18th century newspapers, and 19th century newspapers – all Gale products. Records for these newspapers should be sent to campuses in mid to late October.

4. Vice Chair nomination/appointment

Elaine McCracken (UCSB) accepted the appointment as SCP-Vice Chair/Chair-Elect for 2011/2012

5. Others?

Jim Dooley reported that POT 7 (Transform collection development practices) has held a conference call, and submitted their ideas for lightening teams.

Adolfo Tarango is a member of POT 5 (Maximize effectiveness of Shared Cataloging). Most of the lightening teams for POT 5 will likely have at least one SCP AC member assigned. The various teams will look at possible new and specific areas of cataloging, as well as the decision-making process in prioritizing shared cataloging.
