## Shared Cataloging Program Advisory Committee Conference Call, November 19, 2012: 2-3:30 PM

## 1. Announcements

- Marcia Barrett, new Head of TS, will be new representative from UCSC, replacing Yi-Yen Hayford
- UCI will combine the Collections Division, Technical Services Division (Cataloging and Acquisitions), Special Collections and Archives into one division.
- UCSD: Barnhart has drafted a skeletal org chart for the Program. The new Program includes Cataloging and Metadata, and three new areas are including, rare books, archival processing and images.

## 2. NGM Update (John)

- Quarterly update installed on Nov. 4<sup>th</sup>. The major addition is the Italian interface. - One of the anticipated results of UC's having gone to production with WorldCat Local and formed a
  new Melvyl governance structure (<a href="http://www.cdlib.org/cdlinfo/2011/09/26/new-melvyl-governance-in-place/">http://www.cdlib.org/cdlinfo/2011/09/26/new-melvyl-governance-in-place/</a>) was a Melvyl Strategic Team. Consisting of a subset of ULs, the group would explore with OCLC what other joint collaborations UC & OCLC would want to have following the one on Next Generation Melvyl. On Nov. 30, Karen Butter, Gary Strong, Donald Barclay, Laine Farley, and Ginny Steel will meet in Dublin, OH for a discussion.
- As libraries increasingly weed local collections in view of the titles that have been archived in remote storage facilities, it becomes important to know when the copy in remote storage is not in good shape. If storage facilities can **disclose damaged status at the network level**, potential depositors will have a chance to know a duplicate should not be withdrawn, but passed along for an "upgrade" at the storage facility. John has worked with CDL and OCLC to get public notes like "Damaged" in 852 \$z to display in WorldCat Local, via Z39.50.
- Question: Does the Central Index, which contains licensed material, include everything that we have licensed? Or is it selective? What will CDL turn on and what won't they? John will try to get this information for our next meeting.

## 3. SCP Update (Adolfo/Becky)

- Unpublished congressional hearings: SCP needs to wait on distributing records until the new URLs for the Proquest platform are added to the vendor's records. (Note: this package is available in the Central Index)
- NAXOS records: SCP is looking into getting these new backfile records (appr. 24,000 records). This means we would no longer need institution specific URLs. The cost would be approximately \$400 for the backfile—unless SCP can do it themselves. Records won't likely be distributed until next year. Assuming we continue to acquire records from the vendor for new content, the cost will be approximately \$.35 per record moving forward.
- SCP has started adding package cataloging status to the E-Resources Tracking page under the 2<sup>nd</sup> column. After discussing the status descriptions, SCP-AC requested that Adolfo add a key to the page to explain them.
- Pot 5 received some comments that the page should be re-named. Adolfo asked for input from SCP
- Ivy Anderson will be visiting SCP on Dec. 17th to discuss budget and other business issues. If SCP-AC has any issues for him to discuss with her please send them to Adolfo by Dec 12th.

- 4. JSTOR E-Books: CDL has not licensed these nor is the package under consideration for purchase. If a campus wishes these to be added, a request needs to be submitted to the JSC.
- 5. "Directory of Open Access Books", a package of approximately 1400 titles, is being considered for selection as an open access package. JSC will discuss this in Dec.
