

Shared Cataloging Program Advisory Committee

1. Announcements – none
2. SCP Update (Adolfo Tarango)

SCP has been dealing with some issues with linking in various packages this past week or so. **China Online** and **China Academic journals** have links that aren't resolving. Their vendor seems to change the URLs without notification every year. SCP will be assigning PIDs to solve this issue. **Naxos** has pulled their jazz collection and is selling it as a separate product with new URLs which don't redirect. Kate and Margery are working to make the necessary updates. Naxos Classical and Jazz collections will remain separate. Some campuses may see some deletes in the Jazz collection. **Knovel** will be removing content as well.

Taylor and Francis is no longer a system-wide package. Campuses are deciding what to subscribe to locally. SCP will close their holdings at 2013. Each campus will need to track their local subscriptions and use a local URL for their holdings after that.

Airiti has been problematic. A second set of records will be available come the end of September. Participating campuses should delete the first batch of records loaded and then load the second batch to clean-up issues with the first load and add new titles.

The **YBP-Ebrary Pilot** is moving forward. SCP has been given the go-ahead to process records for it. The records will not be enhanced with Table of Contents. OCLC records will either be used or created if none exist for participating campuses. The initial load will be 2400 records or so, with about a dozen records distributed weekly in the SCP file thereafter. When a title is purchased, an updated record will be sent out in the SCP file. Records will have a 793 field of UC Ebrary DDA Pilot. Purchased titles will have a differing 793 yet to be decided.

The new AC list (**SCPAC-L@LISTSERV.UCOP.EDU**) is live. If others beyond the committee would like to be on it, please contact Sarah Sheets or Adolfo Tarango for review. Adolfo is working on cleaning up the **SCP-L** list for general communications on SCP. **SCP-CATL** has been discontinued and its members will be transferred to the SCP-L list.

CAMCIG met a week or so ago to discuss their place in the new UC Libraries Advisory Structure. They will probably transition to a Common Knowledge Group (CAMCKG?). Wanda Jazayeri is currently coordinating the paperwork to do so. Adolfo and Sarah had a call to discuss SCP-AC's role in regards to CAMCIG last week. Both agreed that SCP-AC and CAMCIG should remain separate in identity and scope and that SCP should have representation on CAMCIG. Adolfo will represent SCP and details of the relationship between the two groups will be further delineated once CAMCIG has determined their place in the new Advisory Structure clearly.

CDL is currently exploring the workflow that occurs with ebooks through a task group.

Becky Culbertson is currently telecommuting half-time.

Adolfo raised the discussion topic of **what constitutes an online resource per RDA cataloging**, specifically **should cataloging be based just on the .pdf or both .pdf and homepage/landing page of the resource**. The committee agreed for cataloging purposes that the .pdf was what should be considered when cataloging online resources.

Adolfo also discussed that there is currently no formalized process for campuses requesting SCP cataloging of single open online resources (vs. packages), that people usually just email Becky. Adolfo asked that here out requests be sent to cdl@www.cdlib.org or <http://www.cdlib.org/contact/> for review and that a form will eventually be created.

3. Monograph vs. serial treatment for editions

Adolfo discussed the treatment of monographs as serials with UCSD biomedical/medical bibliographers. They support current SCP cataloging practice since they feel one record is less confusing to patrons and mitigates the number of links necessary to access titles. The committee agreed that the current practice should continue.
