Open Access Program update

Status of Harvesting Tool RFP

Catherine Mitchell shared about the status of the RFP for software to gather metadata on faculty publications for ingest into eScholarship as part of the Open Access Program. The RFP guidelines were released in August and questions about the proposal have been answered. Comments and progress is included on the OAPI Project wiki ([Open Access Policy Implementation \(OAPI\) Project](#)). Proposals will be submitted October 7, when they will be examined and a software selected by members of the review committee, including LA, SF, and I campus representatives. The vendor is planned to be chosen by November 15, 2013.

Deposit

CDL is interested in attracting comments from faculty interested in the deposit workflow or ingest. Felicia Poe (CDL) and Justin Gonder (CDL) are preparing a proposed workflow for demonstration. The workflow model will be shared with SCO, UCOLASC, Academic Council, SLASIAC and SAG1. Testing will happen in September and October. Release will be on November 1. CDL is working to address faculty concerns that the interface be easy to navigate and workflow be accommodating of their time and office work support.

OA Fund Pilot (All)

Anneliese shared that SAG1 will hold an in-person meeting September 27. Sherri suggested that SAG1 could propose SCO become a knowledge group.

SD: The OA Publishing Fund started with \$20K and had an additional \$20K added. The submissions are slowing as the criteria for submission has been tightened. Funding to hybrid publishing funding is decreasing.

Susan questioned the influence of the OA publishing fund on where a faculty member chose to submit their work. Were faculty intending to publish in the journals selected and chose to use the library publishing funds?

Sherrie asked if the OA publishing funds have a purpose and goal. Are they to encourage faculty to publishing OA venues? Is this support having that effect?

Nancy mentioned that UCSD started with a \$1K limit on funding, but has since increased to the total amount of the article page charges, up to the limit for articles. The decision to withhold funding from authors with research funds that support publishing may be lifted.

Sherri mentioned that faculty members on Academic Senate committees didn't like that researchers with external funding were not eligible for Open Access Fund support. They felt that although they've received grants that the amount received is not enough.

Angela mentioned that faculty could have grant support but not dedicated to publishing costs.
