SCO Charge Discussion

SCO Charge (6/2 revision)

The SCO charge was not discussed at the last CDC call.

This version is a product of a few members of SCO. There were many favorable comments about the most current revisions; specifically the new structure of the document was well received. Barbara has been collecting comments/suggestions for the document. If you sent comments and haven't heard back from her, please let her know. The goal is to come with an overall framework for scholarly communications. Need feedback on whether comments from our last call have been successfully incorporated into the document. Final version of the charge should be ready for CDC to review at their July meeting.

The addresses the fundamental challenge of awareness of scholarly communications by unifying our message and providing best practices.

- Question as to whether we should seek input on the charge from other librarians outside the SCO group. This could be a way to raise librarian awareness about the issues surrounding scholarly communications, even if they don't end up providing direct input.
- Question as to whether the ULs will get this document. Probably not since charge came from CDC. Once it is finalized, CDC may want to publicize/disseminate. Once it is finalized, the document could be sent to Jim Dooley from Merced for distribution. Could also be shared via CDL users council.
- Question about whether this new charge will replace charge on the website. The two charges are related so changes to the website will have to be made.
- Once finalized and approved, SCOs will start using this as our working agenda.

Undergraduate Repository Initiative

There hasn't been a huge uptake yet because everyone is so busy with new system. Haven't been actively marketing. When interested parties

contact CDL, they get the backend set up, but are waiting to add content. Hopefully in the fall they will be able to pursue acquisitions more.

There will be a way to filter out undergraduate content when searching eScholarship.
