

# **CDL Review**

Overview Prepared for March 16, 2011 SLASIAC Meeting

### Context

- The budget crisis affecting the University of California (UC) has resulted in the many divisions, departments and units that comprise, or are affiliated with, UC to evaluate current operations and identify ways to improve efficiency and quality of service. The University Libraries and California Digital Library (CDL) are similarly under pressure to maximize the efficient use of library resources.
- As such, the leadership of the CDL would like to understand what customers value in the services provided by CDL and identify ways to enhance or increase the value of services delivered to its customers. Key questions that CDL would like to answer include:
  - What value does CDL currently provide to the University?
  - Are there CDL services that do not add value to the University?
  - Is CDL positioned to serve the future needs of the University?
  - What course corrections should CDL make to meet the service needs of its customers?
  - What are the trade-offs of pursuing a new direction?

# Approach

- Review Steering Committee: charged to review the results of data collection, validate themes, confirm and prioritize recommendations.
- Consultant Mary Beth Baker engaged to direct the review process.
- Self Assessment written by CDL: reviewed by the Steering Committee and consultant Baker.
- Interviews and focus groups: conducted by Baker with the Review Steering Committee
  - University Librarians
  - Senior library managers represented on the Systemwide Operations and Planning Group
  - UCOP and campus stakeholders representing IT, educational technology, research, publishing
  - CDL leadership and staff
- To understand CDL's position in the national landscape, Baker and members of the Steering Committee conducted a series of interviews with five peer organizations.
