**Decision:** CoUL approves submission of an MPI proposal based on the costs and responsible parties laid out in the SILS Timeline for Major Milestones and Expenditures (endorsed at the Nov. 2018 CoUL meeting). After the working draft is socialized with Nelson and the Provost's Immediate Office, Günter and Chris will finalize the MPI proposal. A copy of the MPI proposal will be circulated to CoUL on Jan. 14.

Meeting date: 14-Dec-18 Minutes last updated: 2-Jan-19 **Decision:** CoUL would like the SILS cost model principles to include principles that appropriately address fairness and equity, present operational realities (e.g. the RLFs, the Shared Cataloguing Program), and future-oriented goals (i.e. principles that support metrics relevant to the evolution of academic libraries and transformative services).

Action: The SILS Working Group will charge a task force (including some SILS working group members and those new to the SILS cohort) to build on the groundwork already established to develop and finalize SILS cost sharing principles. Following CoUL endorsement of the principles, it's likely that the task force will subsequently be charged to define SILS cost sharing metrics and ultimately cost sharing models for CoUL to review and endorse.
