2. OCLC symbols and potential lost revenue in ILL (10 minutes--Newborn email from 8/14/12)

- Discussion centered on the two new OCLC codes for each campus XXXER and XXXSP.
- These two new symbols create issues for non-UC institutions who have our standard symbols in their custom holdings, and they may not be aware that we may have material using these other OCLC codes.
 - We start to lose revenue at this point, because the request goes to the next supplier listed in the borrower's custom holdings.
- Additive versus Substitutive approach to cataloging these records:
 - SRLF is using the additive approach to catalog these records. There isn't an easy way to remove the main symbol, but it is a lot easier to add a symbol.
 - NRLF is using the substitutive approach to catalog these records.
- XXXER records:
 - o ER records are coming up as non-suppliers.
 - In order to make these records visible for borrowing, the group is recommending the additive approach to cataloging these records.
- ACTION: Sarah Troy will draft a letter to SOPAG to address our concerns.

RapidILL (15 minutes -- Newborn)

- Should we ask CDL to work on making a closer link between RapidILL and VDX?
 - o Both RSC and IAG prefer that CDL dedicate their time on VDX 6.0 implementation.
 - There was no great amount of usage for the Linda Hall collection to warrant anytime making VDX work more closely with RapidILL.
 - We will review the need to create a close link between these two systems, if the demand warrants it.
