### **Digitization Common Knowledge Group Charter**

## 1. Summary and Background

The Digitization CKG is a standing group of experts in the area of format migration and digitization of materials. The Digitization CKG communicates with and provides support to the UCL Advisory Structure, but it is not a decision--making body.

### 2. Scope of Work

The Digitization CKG will share information about technologies, equipment, workflows, and digitization standards for materials in all formats held by the University of California Libraries. Topics will also include best practices for large file management and quality assurance of digital files. When topics cross into areas of expertise of other common knowledge groups such as born digital materials, preservation, and metadata, the Digitization CKG will communicate with them and gather their input.

# 3. Key Responsibilities

The Digitization CKG key responsibilities are to:

- Respond to queries and requests received from primarily SAG2 and SAG3, but also SAG1 and other UC advisory structure groups as appropriate
- Gather and share information about the environment, project opportunities, new technologies or practices, and local campus developments within the area of digitization.
- Receive and discuss ideas from various UC constituents, assessing potential for new Systemwide services and/or service improvements.
- Conceive and advance innovative ideas, services, and/or improvements relevant to the UC Libraries systemwide Plan and Priorities.

### 4. Membership and Terms of Appointment

Membership is open to all levels of staff interested in and responsible for digitization. This includes managers, project managers, and hands-on practitioners. To seek membership, interested parties should contact the chair. The group will include librarians and staff representing the 10 UC campuses as well as members from the California Digital Library.
