		The SILS-WG greatly appreciates DOC's support for the upcoming DOC-sponsored SILS webinar (scheduled for July 23 at 1pm). The SILS project continues to run on schedule; the RFP submission window closes on July 17 and virtual vendor demonstrations will be scheduled for July 29, 31, Aug 3, 5 and 7. Two harmonization pilots are underway, both starting with an inventory of current UC practice: the first on student loan periods (being carried out by the Heads of Access Services), and the second on local use of the 9xx fields (being carried out by the Cataloging and Metadata CKG). The SILS Cost Share Task Force presented to CoUL on potential cost models and is now working on a revised model based on that discussion. SILS Governance Task Force update (Troy) SGTF has met twice and will meet next on July 19. A subgroup is interviewing 3-4 peer consortia about their governance models (decision-making mechanisms, migration pain points, how they maintain nimbleness, lessons learned, etc.); they'll bring their findings back to the task force. Upcoming work includes brainstorming governance use cases, and Poe will provide an overview of UCLAS (now and in the past).	committee (Poe, Troy, Barclay) will discuss SILS communications/ updates to DOC, what a more detailed/formal update might look like, and when that might happen (if it should).
