Announcements (All)

Welcome to Stella Tang who is replacing Jason Dezember as our UCB representative.

Updates from SILS Phase 4 Groups

Resource Management Functional Group (Liz)

- Finalizing test scenarios and starting to plan out some cross-FG testing
- Also starting to talk about OCLC/WorldCat updates and trying to put together a collection to test during test load - there will be one UC collection. We can put limits on the collection and exclude certain records from updates
- Working with CDL to talk about possible direct NZ accounts for some specific scenarios
- Bib/holding moratorium in place until 5pm 2/25

Acquisitions & E-Resource Functional Group (Sarah Sheets)

- Focused on waiting for test load
- Drafting document on best practices for fiscal close practices
- MVP development

ILS Data Cleanup Group (TJ)

- The group met the second time this year last Friday. Members shared their initial discovery of test load surprises.
- Once more information is gathered, the group will begin working on more data cleanup recommendations.

SCP SILS Phase 4 Update (Shi)

- CDL IZ data was delivered early January, data are as expected
- CDL NZ data was delivered Feb 12, one week earlier

- P2E data looks as expected and numbers searched in Alma match the number provided in the report
- Bib records has about 1000 records short as result of multi-match within SCP and Marcive
- There are issues with “available for,” bigger one is that it turned on at collection level which CDL resources are at portfolio level for different participants for some collections
- For overall NZ bib and P2E numbers: found not match by Alma search, ExL is investigating and let us know

Early observations about test environment

**Liz can provide assistance with handling multi-match reports in analytics

UCSC (and to a lesser degree UCSD)

- A number of years ago enriched their records with URIs. Since they were late to load into the NZ, all the URIs were lost

UCSB

- POLs are not viewable. Ex Libris says it is an indexing problem. Recommend that all campuses investigate their POLs

UCM

- Still waiting for their instance. There were problems getting their data out of WCM, particularly print holdings data

UCD

- Seeing fair number of multi-matches due to duplication between UCD main library and Law library

UCLA

- ~2,000 multi-matches. Many match on a campus that loaded later than UCLA
 - This may happen because campuses with newer and older 035a OCLC numbers load into the NZ. If UCLA has an 035a and 035z that match both, it appears in the multi-match report

SCP Updates (Shi, Becky)

Cataloging update:

- Deletion of Dacheng brief records sent out today to campus along with new OCLC brief records; there are still a few to be worked.
- Chinese Phase II serials records: will work on after new purchase of Airiti DDA records are distributed

Update on CalDocu: (based on a recent inquiry)

- SCP has no longer actively cataloged CalDocs when the position was eliminated in 2010(?)
- SCP does maintain the records we’ve already distributed with regards to broken links or content no longer available online.

- Current CalDocu records SCP maintain and migrate to Alma NZ
 - CalDocs analyzed serials (180)
 - CalDocs online databases (79)
 - CalDocs online journals (1239)
 - CalDocs online monographs (6959)
- Which campuses are actively cataloging CalDocu?
 - UCSB: print (some backlog); mostly mono, serials mostly title change
 - UCSD: print and electronic
 - UCD: by request only
 - UCB: will ask
 - UCI: generally catalog titles given by Gov doc librarians for print and also online if readily; mostly mono
 - UCLA: get titles from one selector (mostly senate and assembly committees)
 - UCSF: no
 - UCM: no
 - UCR: will check -- (2.25 update) print and e, but only depository materials determined by Collection Strategists
 - UCSC: no longer catalog but will check
- TJ looked at the WMS collection, California State Documents - Electronic. It has 6220 in it now. The last update is November 15, 2020

Routine cataloging delay

- A [draft announcement](#) has shared with JSC members for input, will be posted on CDL website March 1
- Any Collection cataloging requests will be held off until post-migration

- Also concerns about how long the server will last
- Maintenance is pain that you have to do it manually one by one
