New and ongoing projects are advanced at the systemwide level to further <u>the UC Libraries' long range</u> goals:

- 1. Enrich the systemwide library collection
- 2. Maximize discovery of and access to information resources
- 3. Optimize and develop shared services for operational efficiency and maximal expertise
- 4. Expand engagement in scholarly communication

This plans and priorities document outlines the annual systemwide projects and time-limited activities that involve multiple UC Libraries Advisory Structure (UCLAS) and/or project-based teams and require regular engagement with the Council of University Librarians (CoUL) and/or Direction and Oversight Committee (DOC). The work outlined herein should also be considered and reflected in other systemwide work areas and operations, as appropriate.

Many important activities will evolve such that they are operationalized and/or no longer require significant and sustained engagement with CoUL or DOC; while these items will transition off of this time-limited list, they remain important and valued work areas by UCLAS leadership.

1. Launch the Systemwide Integrated Library System (SILS)

Complete phase 4 of the Systemwide Integrated Library System (SILS) project, which commenced in March 2020 and focuses on implementation, data migration, policy/procedure standardization and SILS shared governance. Pursue an improved faculty and student user experience, better library business intelligence, and operational and cost efficiencies through this systemwide initiative.
