Taken together with the Library strategic planning and other visioning exercises, this represents a commitment on the Library’s behalf to supporting collaboration across campus and the UC in service to data management, open data, and the research enterprise more broadly.</p> <p>Geisel Library renovation is progressing, with a target completion date of September. There will be a new entrance with a “meet spot”, an</p>

					<p>Integrated Service Hub (ISH), an active learning classroom, and a refreshed exhibit space. The ISH will feature a LibDispenser automated unit for reserves and holds from MK solutions. The goal is to extend the availability of holds/reserves into evening and overnight hours with minimal mediation.</p> <p>Library is moving to RFID tags for all circulation material. Currently comparing bids for the project. Hope to commence in coming months with a projected project period of 22 weeks. This will function as a new security system, but also hope to explore new methodology for collection management including shelf reads / missing identification.</p> <p>Controlled Digital Lending (CoDiLe) – working with SRLF scanning services for an ongoing pilot supporting CoDiLe scanning for reserves.</p> <p>Library received a \$10 Mill gift and the Biomedical Library Building has been renamed the Sally T. WongAvery Library. Scope and mission of the library will not change.</p>
