#### SCP Operations Updates (Shi and Becky)

 CNKI resources impacted by Chinese laws: Beginning April 1, 2023, access to several CNKI databases at <a href="https://oversea.cnki.net">https://oversea.cnki.net</a> will experience temporary suspension of full text download access or suspension of database-wide access as a result of an audit to ensure compliance with Chinese laws

- regarding cross-border data. The audit focuses on databases with content in the following areas: dissertations, conference proceedings, patents, and statistics. For details, read the <u>full CDLINFO article</u>
- Update on DeGruyter Trial: Titles from the 6-month trial of De Gruyter Ebooks including the University Press Library are available through UC Library Search. The trial started on March 7, 2023 and will run through August 31, 2023 for complete backlist and frontlist titles (through 2023). For details, please read the full CDLINFO article.
- GOBI records
  - for 2022: still waiting for confirmation from GOBI whether they have completed sending records for 2022 collections (Cambridge, Springer, and Wiley).
  - Started received and loaded 2023 frontlist for Springer English and German collections respectively
  - No new records received yet for 2023 frontlists for Cambridge and Wiley
- The Russian Federation has turned off access to some ebooks in some of the aggregators' collections (i.e. EBSCO), we will be relying on the aggregators to update the titles in their collections
- ACTION ITEM for all: Are your campuses comfortable having separate process for OA requesting/approval? i.e. for OA CZ/CDI activation requests, no stakeholder approval is required.

- NZ Elsevier portfolios with coverage different from CDL entitlement
  - o <u>Title examples</u>
  - The coverage discrepancy has resulted in numerous troubleshoot tickets for UCD ER unit
  - O UCD's tentative solution: active the same CZ portfolios, add local coverage according to the "real" entitlement, and check if NZ portfolios have been corrected later
  - O Question: Is it possible to correct the coverage?
  - Shi recommends sending the information via a CDL Helpline ticket to investigate/rectify.
