#### **Resource Management**

• Working on cleaning up local notes in 590-599 of Network Zone bibliographic records. Will work on identifying NZ bib without OCLC numbers next

- Working on updating Local bibliographic data (5XX-9XX) page to include some post-migration changes, such as 590 notes used by CDL, records without OCLC numbers being allowed in NZ, and the new mechanism to prevent campuses from adding 590 notes
- Still waiting for the Operation Team's decision on Proposal for Expanded NZ Access

## Acquisitions/E-Resources

- Drafting a Best Practices guide for troubleshooting e-resource issues: who to contact in each situation, what information to include, etc.
- Assisting Discovery group with testing for exclusion of CDI ebooks when matched in CZ in an attempt to deduplicate items. Currently a lot of caveats/issues via testing.

# SCP Operations Updates (Shi and Becky)

- SCP related liaison contact page has been removed from CDL SCP website
- Becky reviewed and cataloged some title in EBSCO Edusource that have replaced CZ skimpy records
- Continue to work on adding some new contents and updating resources with platform transition
- SCP would like to stop use 930\$g which used for the status of records, mostly journals within a package: a= active, i=inactive, m=has moving wall, will rely on coverage data in portfolios
  - Shi will send email to campus for input
  - UCM, UCSC have not used it
- Shi is working on prepare ARL ebook statistics for campuses which plan to get ready for CDL to share next week with campuses
- As part of RM cleanup local note in 590-599 in NZ, we found that some CZ records also have 59x being kept after CZ bib being replaced. Kate has updated normalization rule to add 59x to the remove list for CZ bib records being replaced including non-OCLC 035 for CZ providers, 906. We just updated it in production. Kate runs a job every Monday to use this rule to cleanup bib records that replaced CZ bib

• BIBFRAME (BF) descriptions in Network Zone of Alma Sandbox (UCD) As a member of Ex Libris Linked Data Focus Group, UCD is testing the BF description workflow in Alma and OCLC. After getting a green light from the Resource Management: Cataloging & Metadata Operations Subteam on allowing BF in the Network Zone of Alma Sandbox, UCD will put some BF descriptions soon

- For what it's worth, UCSC disabled 776 linking in Discovery because Primo VE populates a title proper (245 \$a only) search, rather than using \$w system numbers.
- Can the import profile be modified to drop the 856 field from the bib record once the data is mapped to the portfolio. Display of the link should thru the ERM only. Displaying bib 856 field gives users a link that is not proxied.
