**Announcements (All)**

- UCSC
  - Recruiting for a new position, [Cataloging Specialist](#), to do original & complex copy cataloging with a focus on streaming & physical media. IRD is March 25.
  - Formed the new Library Strategic Planning Steering Committee consisting of six librarians and two staff members. The group will be led by Sarah Lindsey and will work with DeEtta Jones consultants to shepherd the library through an inclusive, user-engaging, and forward-looking strategic planning process. One of the mandates for this group is to listen to the library community and stakeholders so that all voices are heard in the Strategic Planning process.
  - Reviewing Alma & PrimoVE NERS Enhancement Requests Round 1 and will cast institutional votes soon.

  - Sinopia/Alma Sandbox integration is back in business (integration got broken when the sandbox was refreshed). Will begin preparing for presentations for SILS all chairs and other CKG meetings to share the progress, potential impact, etc.

## **Updates from SILS Groups**

### **Resource Management Functional Group**

- Working with CDL/SCP to figure out ETD workflows
  - RM-OST/CDL meeting notes: <https://uc-sils.atlassian.net/l/cp/xBGkX6tn>
  - CDL presented it's preliminary plan on integrating the record ingest process into NZ using the ETD app.
  - One of the challenges is how to publish holdings to OCLC. More investigation and discussion are needed among RM-OST/CDL/SCP (SCP piece would be particularly important).
  - See below for more discussion
- Considering using CDL's GitHub repository to keep track of all Network rules (TJ's plea: there is an Alma enhancements proposal, NERS 8825, about making version history for Normalization Rules, Merge Rules, etc. available. Please consider voting for it so we don't have to use tools outside Alma for this task.)

### **Acquisitions & E-Resource Functional Group**

- Perpetual rights and entitlement tracking in Alma DRAFT - gathering information on how each campus currently tracks
- Lisa Wong will join next mtg (3/28) to demo dashboard for NZ/IZ record overlap via Alma Analytics.

- ACRL statistics completed, working on ARL statistics.

- Reviewing a webinar on considerations for creating problematic language statements and statements from other libraries with the goal of creating guidance for campuses who have not yet created such public-facing statements
- Discussing responsibilities of the to-be-recommended standing group for DEIA metadata in Discovery and justification for the proposal

## **SCP Updates (Shi, Becky)**

- **JSTOR Archival Journals and Primary Sources Collection:** Completed transition for CDL upgraded subscription for this all collection. All former collections have been deactivated and removed in the NZ
- **BUDA (Buddhist Digital Archives):** Completed transition from formally Tibetan Buddhist Resource Center (TBRC) Core Text Collections 1-9 (or 1-10). Now the platform changed its name to BUDA (Buddhist Digital Archives) for free access with a registered account required to download full text. However, because CDL purchased content and we have IP access that gives us FT downloads without registering.
- **CRL Global Press Archive:** It is a mix of CRL IP-restricted and open access content that will be produced over several years. CDL ERT has reviewed and identified phase 1 & phase 2 collections for CRL-wide and open access. SCP has been cataloging these collections and has set access in the Alma Network Zone.
- **ETD workflow from RM:** SCP staff are currently reviewing the workflow CDL proposed

- “er” symbols are not included in Worldcat Daily update. The question about the utility of the symbols is surfacing again
- Campuses handle ETD in a variety of ways now– campuses that are concerned about the OCLC records set holdings and those that are not concerned do not.
- SCP and CDL will explore options for OCLC holdings workflow
- ISBN time lag does not seem to be a concern.
- There are also deduplication issues.
