# **SCP Updates** (Shi, Becky)

- Working on ProQuest History Vault and UNAM (only 180 titles to go)
- CDL Shared Collections staff (SCP, CDL Acquisitions, E-resource team) reviewed, discussed and prepared feedback to the following documents:
  - Guidelines for Cataloging and Making Accessible Open Access (OA) Monographs in the Network Zone
  - Network Zone Principles & Operational Guidelines
  - Network Zone Account request process
- JSTOR DDA: still learn and explore the process, and communicate with GOBI about outstanding issues; will meet with UC EBST members to provide updates
- Cataloging of OA resources: Most campuses don't have many or/and choose not to catalog OA
  resources. UCLA has two local collections for OA resources, including both monographs and
  serials. If you have more information about how your campus manages OA resources, please
  share it with Becky

#### Other

- Renee: If an individual campus and CDL/SCP have activated the same portfolio (regardless of whether the content overlaps), the locally activated portfolio overrides the display of CDL's NZ portfolio. Two ways to remedy this is to delete the campus IZ record, or to create standalone/local portfolios for the serial title so it doesn't interfere with the CDL managed NZ access. How do other campuses deal with this problem?
  - Catherine: consult E-Resources OST on best practices on handling this situation. At least, documenting this situation. It appears there is already a SILS document on this subject:
     Best practice for activating a CZ portfolio in both NZ and IZ
  - Jason will bring it to the ER OST
  - Shi: need some examples to figure out what's the best way to handle this situation
