### **Updates from SILS Phase 4 Groups**

#### **Resource Management OST (TJ)**

- Submitted a request for loading WorldCat records for GovDocs to SCP. Wait for the new SCP head to join any necessary discussion/decision
- Continued working on finalizing specifications for ProQuest ETD records with CDL. Waiting for the latest update from CDL.

#### **Acquisitions & E-Resource Functional Group (Sarah)**

- Focusing on the Scoping of IP ranges draft.

#### **Ethical & Inclusive Metadata Practices in UC Library Search Project Team (Marcia)**

- Final report/recommendations have been submitted and the group's work is done. Waiting to hear from OT regarding the next step.

#### **SCP Updates (Shi, Becky)**

- The Request Form for Adding Individual OA Monographs to the Network Zone is now live
  - Both the request form and the guidelines were approved by JSC in early January
  - The guidelines will be updated and finalized as we start this new workflow and may receive more input from campuses.
  - CDL is continuing to work to update the [Policies and Procedures page for Open Access Resources](#) to reflect these changes and will be posting the new [Guidelines for Adding Individual Open Access Monographs](#) document to the website as well. CDL will keep SCP-AC updated on these changes.

- The Draft Request Form for Adding CalDocs Titles is now ready for SCP-AC members and campus colleagues to review and provide input.
  - This was to respond to a query emerged regarding the inclusion of California Documents (CalDocs) titles in the individual OA monos request form
  - SCP has maintained CalDocs as a distinct collection within the Alma Network Zone and has opted to develop a separate request form specifically for CalDocs titles.
  - The request form will accept requests for both books, journals, and other formats of CalDocs once approved by SCP-AC and JSC. Cataloging responsibilities will be clarified. Journals and databases will be cataloged by SCP.
- Taylor and Francis Journals Gap clean up: As January 1, 2025, Taylor & Francis will be aligning the backfile access with the terms of UC [transformative agreement](#) (2024-2027). We do not anticipate that this change will be highly disruptive as the content is primarily older and receives low use. Several CDL ERT staff have been working on aligning content availability in Alma with the actual availability of content on the Taylor & Francis platform.

UCLA noted that there had been issues with links to T&F articles appearing in Primo.
- Springer 2024 eBooks: CDL has finally reached agreement with Springer Nature on acceptable AI terms for the systemwide ebook license, enabling signing of the license for 2024-28. The 2024 Springer ebooks are accessible at the vendor site, and the 2025 ebooks should be accessible soon. CDL ERT staff have been evaluating and determining the best way to provide access to these eBooks.
