Updates from SILS Phase 4 Groups

Resource Management OST (TJ)

- Continue working on cleaning up local 9xx notes showing up in NZ
- Discuss if campuses change their cataloging practices due to Library of Congress's adoption of "Modern MARC"
 - Several campuses have not discussed this yet, but some have Primo configured to display separate LCSH heading and genre/form terms. Making LCSH more linked data compliant and avoiding duplication in records would be useful, especially in music cataloging.

Other

- Does SCP need a policy/procedure for handling Subscribe to Open? (Catherine)
 - Example: Opening the Future – Central European University Press
 - **“Please share this information as needed** with your local team members who process eBooks in your Alma IZ. Over the years FY2022-FY2024, the UCs supported the **Opening the Future – Central European University Press (CEUP)** program to fund open access publishing. Each UC campus chose a different package to support:
 - Political Science Package: Davis, Irvine, Los Angeles, Riverside, Santa Cruz, Berkeley
 - History Package: Merced, Santa Barbara
 - Library Selection Package: San Diego
 - (San Francisco did not participate)

Because the UCs supported this program for 3 years, each UC now has perpetual access to the package they supported. We are sending this as a reminder to you. Because each UC chose a different package, these were not managed centrally in the NZ. If you did not process these books in your IZ, you may wish to do so now.”

- Normally Subscript to Open requests come in as OA requests from bibliographers, but if it’s a resource managed in the NZ that becomes open, SCP will get notifications from vendors.
- This example is different because it’s managed locally. The policy could say that it becomes managed centrally when it becomes open, but the complication is that not everyone subscribes.
- Should we consider this as Tier 2 or Tier 3? Do we need to put in an OA request for cases like this? Is there any indication of Subscribe to Open in protocol?
 - It should be Tier 3, but reach out to Laura Fouladi or Sherry for clarification.
 - Subscribe to Open could be added as an option on the access form.
